



REVEREND MONSIGNOR JEREMIAH O'SULLIVAN

<u>June 13, 1925 - January 5, 2021</u>



It is with heavy hearts we announce the passing of Monsignor Jeremiah O'Sullivan, 95. He passed away peacefully on January 5, due to complications of COVID. Father Jerry was born in The Spa, County Kerry, Ireland in June, 1925 to Michael and Hannah Mary O'Sullivan; the eighth child of fifteen. They lived on a dairy farm overlooking Tralee Bay. The eleven boys helped on the farm, while the four girls helped their mother. Though very hard times, they had enough to feed the family as well as many of the neighbors in need. In the summers they would escape down to the water to swim. They loved being in the water.

Jerry joined the Dublin Police force at the age of 20. He enjoyed being a Dublin Garda. He carried a gun with no bullets. He never wanted to hurt anyone; he only wanted to help. Once, as the Dublin rain got heavy, he ran across the street for cover by the door of a jewelry store. When he found

cover, the door of the store opened as a thief was exiting. The thief saw a cop, dropped the bag of jewels and put up his hands. Jerry's supervisor recommended a medal be awarded for the arrest. Jerry explained that it was pure happenstance the thief surrendered, but he still received the medal

He left the police force at age 24 when he received a letter from his brother, Martin, stating his intention to go to America and asked his brother, Jerry, if he would like to join him. They were sponsored by an uncle in St. Louis, Missouri. After getting their visa, they were on the boat. They lived in St. Louis for 18 months.

Father Jerry had decided to become a priest and in 1951 he entered the seminary in San Diego. He was ordained March 19, 1958. His first Mass was celebrated at Our Lady of the Holy Rosary in Sun Valley, CA where his brother, Martin, is a parishioner.

He served at many churches in the San Diego Diocese; starting with St. James in Solana Beach as an associate. He was an associate at St. Pius X, Chula Vista; and Immaculate Conception, Colton. As Pastor, he served at The Immaculata, San Diego; St. James, Perris; Holy Family, San Diego; St. James, Solana Beach; and Sacred Heart, Coronado until he retired in 1996. He continued to help at Sacred Heart as long as his health allowed.

He loved being a priest. His homilies and eulogies for those who had passed were beautifully written and delivered. He had a way with words that could bring you to tears or make you laugh. The many pilgrimages he led to various countries inspired many. He celebrated Mass at Nazareth House a few weeks before he died. The director said she had never seen a resident priest continue his priestly duties until the end of his life. It was very inspirational to those in attendance. He spent hours praying every day and did so much for his parishioners. And they, in turn, did so much for him. While at Nazareth House, his former parishioners from various parishes, as well as family and friends continued to visit him, invited him to their homes for holidays, took him out for lunch and were good friends to him.

Father Jerry had many talents. He loved to paint, especially landscapes of Ireland and flowers. Many of his beautiful paintings were donated to various causes, given to family and friends, and he kept many as he enjoyed the memories of home. As he was a great photographer, he used his photos as inspiration for his paintings. If anyone has received a card or letter from him, you know his calligraphy was beautiful. Reading was important to him and he collected numerous books. Coming from a musical family, Father Jerry played the violin and loved music. All of his brothers and sisters either played an instrument or sang; and most were very good! Visiting Ireland and family brought him joy and he would visit home often. People loved Father Jerry and he loved people. He could meet someone once and they would feel they have a new friend. It didn't matter where you came from or your position in life. He had a gift of being able to connect with others. Friends ranged from anyone on the street to famous musicians, directors, photographers & Hollywood stars.

He is preceded in death by his parents (Michael and Hanna Mary); his brothers: James, Paddy, Sean, Michael, Tommy, Brendan and Eamon; sisters: Bridget and Anne (Sr. Maria Goretti) and nephews: Thomas and Jeremiah. He is survived by his brothers: Martin, Liam and Florry; and sisters: Hannah Mary and Mary. He was a favorite uncle to his thirty-seven nieces and nephews as well as great and great-great nieces and nephews.

He had an amazing life, a great sense of humor, and loved others. He will be missed by many. Jesus, the Eternal High Priest, has called and summoned his faithful servant to be with his Lord, heavenly family, the angels and saints. May he rest in eternal peace.

2/11/56 - 12/18/20





TOM LABONGE



Los Angeles City Councilman, or "Mr. Los Angeles," Tom LaBonge may in part be remembered for his efforts to help the elephants at the Los Angeles Zoo. In spring 2006, amid pleas to free the elephants, the city council voted to keep the world's largest animals at the zoo. in a new exhibit, which included grasslands and waterfalls.

"We have three elephants at the zoo... Right now we have to make it better for them, safer for them," said Councilman Tom LaBonge.

Los Angeles Councilman Tom LaBonge died Jan. 7, 2021 at the age of 67. A graduate of John Marshall High School, LaBonge received his bachelor's degree in sociology from California State University, Los Angeles.

He was a member of the Los Angeles City Council representing the 4th district, serving from 2001 to 2015. LaBonge won a special election to fill the seat left vacant by the death of long-time council member John Ferraro. The district included a wide diversity of incomes and neighborhoods. During his time in office, he was the chairman of the Arts, Parks, Health and Aging committee, vice chairman of the Transportation Committee and the Ad Hoc River Committee, and member of the Trade, Commerce & Tourism Committee, and the Ad Hoc on Recovering Energy, Natural Resources & Economic Benefit from Waste for L.A. (RENEW LA) in the city of Los Angeles. He was a member of the Democratic Party.

Prior to serving as councilman, LaBonge was director of Community Relations at the Department of Water and Power, special assistant to Mayor Richard Riordan, and chief deputy to council president John Ferraro. LaBonge was a lifelong advocate for Griffith Park, one of the largest urban parks in the nation, which fell in his old council district.

He married graphic designer and illustrator Brigid Manning LaBonge in 1988. Prior to his death, LaBonge resided in the Silver Lake district of Los Angeles with his wife and their two children, Mary-Cate and Charles.

Mayor Garcetti And Council President Nury Martinez On The Passing Of Tom LaBonge

"Our hearts are heavy with the passing of former Los Angeles City Councilmember Tom LaBonge. In a city of 4 million Angelenos, Tom LaBonge was Mr. Los Angeles. He was a true public servant who was never afraid to roll up his sleeves or pull a City worker over if a constituent needed help or a street needed servicing at a moment's notice. He knew every mascot of every high school in Los Angeles for a reason – so he could engage people and talk to them about *their* lives. As a councilmember, he took care of his constituents and was a champion of one of L.A.'s greatest treasures, Griffith Park. Tom LaBonge loved

Los Angeles and Los Angeles loved him right back. To quote Tom, he is forever an angel in the City of Angels. May God bless him, his wife, Brigid, and the entire LaBonge family." — Mayor Eric Garcetti and Council President Nury Martinez

"I am still trying to process the loss of my friend Tom LaBonge on Thursday night. The ten years we spent together on the City Council were the best political years of my life.

I directed that the L.A. Memorial Coliseum torch be lit on Friday until sundown in honor of his life.

Nobody loved this city more than Tom and I don't know if anyone ever will. He was and will always be Mr. Los Angeles.

Margaret Gallagher is blissfully happy in her Irish cottage with no TV, electricity or phone

Margaret Gallagher has a beaming smile, a twinkle in her eye and a love of talking...she lives a simple life and couldn't be happier.

Margaret lives in Belcoo in Co Fermanagh in a small cottage that has barely changed in over 280 years.

It was there before the 1798 Rebellion and has remained intact through the union with Britain, the Easter Rising, War of Independence and the Civil War.

It's even survived the development craze and rising house prices of the Celtic Tiger days...so much so that the cottage still has no electricity, TV or even running water.

These are all things that Margaret sees as having a positive rather than negative impact on her life.

She is self-sufficient and keeps out the cold with a roaring log fire, on which she also cooks some of her meals.

She's proud of her Irish heritage and the fact that she, like her ancestors, is steeped in the Fermanagh landscape. For her, genealogy is not a subject for research, it's there in her cottage and surrounding land.

The 74-year-old told the <u>Belfast Telegraph</u>: "There never was a time for transition to something more modern. I was born into this house on January 26, 1942, at five past nine on a Monday morning. My mother died when I was 10, my father died in 1980. His father bought this house in 1887, and my take on it is if it was good enough for them, then it's good enough for me."

She said her family never had much money, but they had love and warmth and kept an open door for visitors. "By God, there was a welcome. There was no intrusion of a television, not that there is anything wrong with a television. I have a wind-up radio which I listen to in the mornings to get the time, the day, the date and the news headlines. The problem with televisions and everything else, there doesn't seem to be an off button ever used."

Margaret's day begins with lighting her fire to bake bread and cakes. She gets her fresh water from a nearby stream.

Fuel consists of turf that's found nearby. "I tell you, I carry some turf, I also carry some water. I was born under Aquarius, but nobody carries more water than I do.

"People come to look at me as if I am an endangered species. That's grand, I am very endangered. But it's for real. I am not here to please an American tourist who is ooh'ing and aah'ing, looking at me, saying: 'I thought people in this lifestyle would have a long black skirt on them'. I say: 'Possibly, but if you see the path I have down to the well, a long black skirt would need a washing'."

Margaret's only concession to modern life is a wind-up radio but for entertainment, she prefers to read. When the weather turns cold she gets in plenty of turf for the fire and bunkers down in warmth and safety.

"I have a wireless radio and listen to the news headlines on that. I brought in plenty of logs and turf and carried in plenty of water, so I was well equipped for it. I have enough water now I could bathe the country for a small charge.

"I had to get up very early the other morning to knock the snow off the roof with a pole. If you don't do that it can damage the roof. It came down with a crash.

"With a house like this you have to prepare for what's coming.

"This house makes a statement, it sits very comfortably on the landscape, even though I am surrounded by beautiful new homes. It says that you can't forget about your past, you bring it with you proudly into the future."

All people must produce a negative PCR test to enter Ireland beginning January 16

Beginning January 16, all people (with some exceptions) arriving into the Republic of Ireland must produce a negative PCR test that was conducted 72 hours prior.

Failure to produce a negative PCR test upon arrival into the Republic of Ireland from January 16 could result in prosecution punishable by a fine or imprisonment.

The Irish Government has confirmed that beginning this Saturday, January 16, all people arriving into the Republic of Ireland must produce a negative / "not detected" pre-departure PCR test.

The negative PCR test comes in addition to the current "traffic light" system in effect for the European Union, which dictates how long a person who arrives in the Republic of Ireland needs to quarantine or restrict their movements for.

Flights and ferries from Britain to Ireland banned over new virus strain

On January 13, new information was shared on the Irish Government's <u>page</u> for COVID travel information which reads: "Effective from 16 January 2021, all passengers arriving into Ireland (except those arriving from Northern Ireland) are required to have a negative/'not detected' result from a pre-departure COVID-19 PCR test carried out no more than 72 hours prior to arrival in Ireland.

"Passengers will be asked to present evidence of their negative/'not detected' result before boarding their airplane or ferry, and will be required to produce this evidence to Immigration Officers on arrival at points of entry to the State.

- "Passengers who arrive in an Irish Airport or Sea Port without evidence of a negative/'not detected' test result commit an offence and may be subject to prosecution, punishable by a fine not exceeding €2,500 or imprisonment for a term not exceeding 6 months or both.
- "International Transport Workers, including workers in aviation, maritime and road haulage sectors are exempt from this requirement where they are travelling in the course of performing their duties.
- "Children aged 6 and under are also exempt from the testing requirement, although they are advised to restrict movements for 14 days.
- "Passengers who arrive in Ireland solely for the purpose of travelling onwards to another state and do not leave the airport are also not required to provide evidence of a test.
- "If a citizen has a genuine humanitarian emergency requiring urgent travel, they should contact the nearest Embassy or Consulate immediately for advice and consular assistance before commencing their journey."

COVID restrictions for US travelers arriving in Ireland set to change from November 29

A <u>statement</u> from Ireland's Department of Foreign Affairs on January 13 added: "Arrivals from Great Britain and South Africa will continue to require a negative/not detected PCR test AND must continue to isolate for 14 days, even if they take a second test after arrival.

- "Arrivals from red and grey list countries (as defined by the EU traffic light system), and all other locations outside of Europe, must continue to restrict their movements for 14 days. However, this may be lifted on receipt of a negative/not detected result of a second PCR test taken no less than 5 days after arrival.
- "Arrivals from green and orange countries (as defined by the EU traffic light system) will not be required to restrict their movements on arrival but must adhere to the local public health guidance.
- "Checks will be made by the Border Management Unit at Dublin Airport and by An Garda Síochána at other points of entry."

The European Centre for Disease Prevention and Control (ECDC) <u>updates</u> which countries fall into which categorization as part of the traffic light system each week. The Republic of Ireland is current a "red" country.

People arriving in Ireland will still be required to complete a Passenger Locator Form, which is <u>available</u> <u>online</u>. Failure to complete the form could result in the issuing of penalties, including a fine of up to €2,500 or imprisonment for up to 6 months.

The Republic of Ireland is currently in the midst of a lockdown under "full-scale Level 5 measures," which prevents non-essential travel further than 2km from your home.

If you are planning on traveling to the Republic of Ireland, you are urged to stay up-to-date with the Irish government's travel advice and restrictions.

Article 6 – Feb. 1, 2021

If you've been investing for many years and you've owned bonds, you've seen some pretty big changes on your financial statements. In 2000, the average yield on a 10-year U.S. Treasury security was about 6%; in 2010, it had dropped to slightly over 3%, and for most of 2020, it was less than 1%. That's an enormous difference, and it may lead you to this question: With yields so low on bonds, why should you even consider them?

Of course, while the 10-year Treasury note is an important benchmark, it doesn't represent the returns on any bonds you could purchase. Typically, longer-term bonds, such as those that mature in 20 or 30 years, pay higher rates to account for inflation and to reward you for locking up your money for many years. But the same downward trend can be seen in these longer-term bonds, too – in 2020, the average 30-year Treasury bond yield was only slightly above 1.5%.

Among other things, these numbers mean that investors of 10 or 20 years ago could have gotten some reasonably good income from investment-grade bonds. But today, the picture is different. (Higher-yield bonds, sometimes known as "junk" bonds, can offer more income but carry a higher risk of default.)

Nonetheless, while rates are low now, you may be able to employ a strategy that can help you in any interest-rate environment. You can build a bond "ladder" of individual bonds that mature on different dates. When market interest rates are low, you'll still have your longer-term bonds earning higher yields (and long-term yields, while fluctuating, are expected to rise in the future). When interest rates rise, your maturing bonds can be reinvested at these new, higher levels. Be sure you evaluate whether a bond ladder and the securities held within it are consistent with your investment objectives, risk tolerance and financial circumstances.

Furthermore, bonds can provide you with other benefits. For one thing, they can help diversify your portfolio, especially if it's heavily weighted toward stocks. Also, stock and bond prices often (although not always) move in opposite directions, so if the stock market goes through a down period, the value of your bonds may rise. And bonds are usually less volatile than stocks, so they can have a "calming" effect on your portfolio. Plus, if you hold your bonds until maturity, you will get your entire principal back (providing the bond issuer doesn't default, which is generally unlikely if you own investment-grade bonds), so bond ownership gives you a chance to preserve capital while still investing.

But if the primary reason you have owned bonds is because of the income they offer, you may have to look elsewhere during periods of ultra-low interest rates. For example, you could invest in dividend-paying stocks. Some stocks have long track records of increasing dividends, year after year, giving you a potential source of rising income. (Keep in mind, though, that dividends can be increased, decreased or eliminated at any time.) Be aware, though, that stocks are subject to greater risks and market movements than bonds. Ultimately, while bonds may not provide the income they did a few years ago, they can have a place in a long-term investment strategy. Consider how they might fit into yours.
